## What are some good general safe work practices?

- **DO** Control traffic on roads and busy access ways near the work site.
- **DO** ensure that prior to commencement of any excavation, ensure that all underground and/or overhead lines being crossed have been identified, follow job plan for trench, excavation or bore.
- DO identify hazards which will be created when auguring equipment is set into position.
- DO ensure that Prior to auguring, determine stability and anchoring of auguring equipment.
- **DO** ensure that prior to auguring provide adequate visual inspection holes in front of each cable, set of cables, and/or line crossing.

- DO maintain visual inspection at all holes when removing Auger bit and rod or when pulling back cable or pipe.
- **DO** ensure that upon pull back, maintain proper clearances and desired line of path.
